We also have plans to open new health centers and continue our growth so that we can meet the goals of our mission. CompleteCare remains strong and steadfast in our goals of taking care of the healthcare needs of the community. We look forward to seeing all of you soon.

# At CompleteCare we are proud of our response to COVID-19.

Our goal from the beginning of the pandemic was to maintain access to quality care for our patients, while also keeping everyone in our health centers safe. We made this our focus every step of the way and feel we were successful in 2020 and remain committed to those goals today.

# **COVID** Testing

CompleteCare was one of the first federally-qualified health centers in the country to begin testing for COVID-19. Through partnerships with the local health departments, CompleteCare created drive-thru testing sites in multiple counties. We were also able to provide testing and education on local farms. In late 2020, we created a permanent testing site in Millville, offering walk-in testing six days a week. In total, from April 2020 through June 2021, CompleteCare has tested over 15,455 for COVID-19.

# **COVID** Vaccines

Providing the COVID-19 vaccine to staff, patients, and members of the community was a huge moment for the CCHN team. In late December we administered the first doses of the vaccine and the organization has held vaccination clinics ever since. CompleteCare has partnered with churches, schools, farms, agricultural centers, and more to ensure that everyone who needed the vaccine received the shot. Through June 30, 2021, the team has vaccinated over 6,752 people.



# Saying Goodbye

CompleteCare faced tragedy in 2020 and early 2021 with the loss of two vital members of our Executive Team. Dong Choo and Karla Pope dedicated their lives to the organization and sadly both died in early 2021.

Dong, our Director of Information Systems, was an integral part of every team and helped CCHN run safely and securely. He was a kind and caring person who genuinely loved his work and his family.

Karla was CompleteCare's Director of Nursing for many years and prior to that a practice manager and nurse for over 40 years. Karla was dedicated to making others better and her presence guided so many at the organization. Her compassion for others and love for her work are missed every day.

# **Maintaining** Access

Despite the pandemic, our patients still needed access to their providers, medications, and treatment plans. To ensure they did not lose touch with services vital to their health CompleteCare restructured its health centers to make them safer for staff and patients to visit. Additionally, we moved any appointments that could be seen remotely to video or telephone visits. In 2020, CompleteCare still saw 51,380 patients for 118,684 visits. 18,625 of those were via telemedicine.






# **BY INCOME**


Information based on percentage of federal poverty level guidelines.




# **BY AGE**

# **BY RACE**



# 2020 Highlights

#### **Vineland High School**

CompleteCare opened its fifth school-based health center in November. CompleteCare at Vineland High School, also known as CompleteCare Hallways to Health is open to all students in the Vineland Public School System. The site features primary medical services, as well as appointments for school and sports physicals and immunizations. In 2021, CCHN hopes to expand services to teachers and staff. We also plan to add mental health services to the site.

#### **Telemedicine**

Connecting with patients who cannot visit the doctor in person is not a new problem, but it is definitely one that has been made easier through the advent of telemedicine services. CCHN's video appointments connect our providers with patients from the comfort and safety of their home. These visits are available for multiple specialties including sick visits, medication management visits, counseling sessions and more. In 2020, CompleteCare providers completed over 18,625 telemedicine and telephone visits.



# **Looking Ahead**

#### **New Locations**

2021 will be a big year for CompleteCare as we open two new locations, one in Gloucester County and two in Cumberland County.

Medical & Dental Professionals, Millville is on track to open in October 2021. This new site will take the place of CompleteCare's current Millville location. The state-of-the-art facility will welcome patient for medical, dental, mental health and specialty services.

Our largest project will be the opening of a new health center and administrative office for CompleteCare in downtown Bridgeton. This expansive location will house our Adult & Specialty Medical Professionals location, a Community Pharmacy and the CompleteCare Health Network Administration Staff including Human Resources, Information Systems, Medical Records and more.

In 2021, CompleteCare will also look for new homes for two other Bridgeton-based locations, their Women's Professionals site and their Dental Professionals location.

#### **Back to Business**

In 2020 many of our plans were diverted by the COVID-19 pandemic. We are hopeful that an increase in vaccine rates and a decrease in COVID cases will make it possible to resume normal activities in 2021. This would include reopening all of our health centers to full capacity, bringing all service lines back for face to face care, and planning and implementing events for our patients, staff and Foundation.

### **Testing & Vaccines**

CompleteCare will continue to provide COVID vaccines and testing to the community for as long as needed and necessary. It is our goal to ensure that everyone in the community who wishes to receive a vaccine is able to do so.



The CompleteCare Family Health Foundation was founded in 2015 to raise funds for programs at CompleteCare Health Network. In other years the Foundation has helped support services such as Baby Love, Reach Out & Read, Health Solutions and CompleteCare's Care Management program. In 2020, the Foundation took action in helping CompleteCare raise funds for protective equipment such as masks, gloves, gowns and hand sanitizer.

As the fundraising arm of CompleteCare, the Foundation board is skilled at pivoting quickly to meet the needs of the organization. They work collaboratively with CCHN leadership to ensure the needs of the organization are being met.
